# MASSACHUSETTS TRI-COUNTY USBC HALL OF FAME

PURPOSE: To recognize and perpetuate the names of those members of the Massachusetts Tri-County USBC who, through either their ability and conduct or their conduct and their tireless efforts to promote, improve and increase participation in the game of American Ten Pins has directly proven beneficial to members of the MTCUSBC and the USBC in general.

#### **Nominations**

Any USBC member may submit the name of a nominee from the MTCUSBC to the Hall of Fame committee of the MTCUSBC. Nomination forms may be obtained from any MTUSBC official. Nomination forms must be completed in their entirety and submitted to the Hall of Fame committee no later than October 1<sup>st</sup>. The Hall of Fame committee shall submit the nomination and the committee's recommendation to the MTCUSBC Board of directors no later than January 15<sup>th</sup>. The nominator will be notified within 30 days of the Hall of Fame committee's decision. To be elected to the Hall of Fame, a nominee must receive at least 75% approval from the Board of Directors of the MTCUSBC. The nominee shall be notified within 30 days of the decision. No more than one nominee from each of the 3 categories can be approved for the Hall of Fame per bowling year.

#### HALL OF FAME COMMITTEE

The Hall of Fame Committee shall consist of members appointed by the Board of Directors of the MTCUSBC. The committee will be 2 MTCUSBC Board Members, 2 MTCUSBC Hall of Fame Board Members and 1 Hall of Fame member at large.

**CATEGORY 1: Meritorious Service** 

**CATEGORY 2A: Meritorious Performance (Open)** 

**CATEGORY 2B: Meritorious Performance (Women only)** 

The nominee will be awarded a plaque or other appropriate gift at the Opening Ceremony of the Annual Tournament and his name shall be engraved listing the accomplishment and showing the date of induction.

#### **CATEGORY 1: (Meritorious Service) (Open & Women)**

a: A nominee must be a member of the MTCUSBC or its previous local constituents for a minimum of twenty (20) years.

b. Particular consideration should be given for service rendered by reason of pure devotion to the game and its promotion relative to the local area. This category would include voluntary work with the MTCUSBC and attendance at out of town or out of state meetings representing the MTCUSBC on a state or national level.

c. The nominee must earn at least 100 combined points in the following areas. Point value will be awarded once for each year of service in each office held. League Positions will be granted per league served.

## **Nominations**

Any USBC member may submit the name of a nominee from the MTCUSBC to the Hall of Fame committee of the MTCUSBC. Nomination forms may be obtained from any MTUSBC official. Nomination forms must be completed in their entirety and submitted to the Hall of Fame committee no later than October 1<sup>st</sup>. The Hall of Fame committee shall submit the nomination and the committee's recommendation to the MTCUSBC Board of directors no later than January 15<sup>th</sup>. The nominator will be notified within 30 days of the Hall of Fame committee's decision. To be elected to the Hall of Fame, a nominee must receive at least 75% approval from the Board of Directors of the MTCUSBC. The nominee shall be notified within 30 days of the decision. No more than one nominee from each of the 3 categories can be approved for the Hall of Fame per bowling year.

#### **CATEGORY 2A: (Meritorious Performance) – (Open)**

- A. The bowler shall be a member of USBC for 20 years and the MTCUSBC for a minimum of fifteen (15) years with a book average documented for each year to be recognized.
- B. The bowler must never have been suspended from competition for any reason whatsoever, except where consideration resulted in a finding of "no cause for action."
- C. Nominee shall have points from each category D-F totaling at least 200 points as outlined
- D. Tournament Participation Max 25 points
  - i. The nominee must earn a combined 25 points from USBC tournament participation as outlined below:
    - a. MTCUSBC Annual Tournament 1 point per year (Minimum of 10 points required)
    - b. State Annual Tournament 1 point per year (Minimum of 5 points required)
    - c. National Open Championship 1 point per year

- B. The female bowler must never have been suspended from competition for any reason whatsoever, except where consideration resulted in a finding of "no cause for action"
- C. Nominee shall have points from each category D-F totaling at least 150 points as outlined
- D. Tournament Participation Max 25 points (75% must be in Women's not Open entries)
  - i. The nominee must earn a combined 25 points from USBC tournament participation as outlined below:
    - a. MTCUSBC Annual Tournament 1 point per year (Minimum of 10 points required)
    - b. State Annual Tournament 1 point per year (Minimum of 5 points required)
    - c. National Open Championship 1 point per year
